**WAIVER AND RELEASE OF LIABILITY AND ASSUMPTION

1. Agrees that prior to participating, he/she will inspect any facilities and equipment to be used, and if he/she believes anything is unsafe, he/she will immediately advise a club officer of such condition(s) and refuse to participate.
2. **ACKNOWLEDGES AND FULLY UNDERSTANDS** that each club member will be engaging in **ACTIVITIES THAT INVOLVE RISK OF SERIOUS INJURY, INCLUDING PERMANENT DISABILITY AND DEATH**, and causing severe social and economic losses which might result not only from his/her own actions, the inactions or negligence of others, club rules, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known or not reasonably foreseeable at this time.
